

Greetings Fellow Alumni,

Thank you for your interest in serving on the CMU Alumni Association's Board of Directors. The Association is an active and passionate group of alumni dedicated to fulfilling their mission of building and cultivating relationships to benefit the alumni, students and faculty of Colorado Mesa University.

We put together the following outline to help you determine if serving on the board fits you and your other commitments:

- **Leadership:** Foremost directors are expected to provide pro-active and engaged leadership for the members of the Association.
- **Financial Commitment:** Alumni are the backbone of the University and they are very instrumental to its future. It's important that the board of the directors serve as an example to all alumni and other donors with its 100% participation in giving back financially to the University. The amount of the contribution is up to you, but each director is expected to make an annual donation.
- **Time Commitment:** Between meetings, preparation for meetings, events and projects you can expect to invest between four to six hours per month on average. Terms are two-years in length.
- **Meetings & Attendance:** The full board meets on campus every-other-month on the second Thursday of the month, beginning in July with our Annual Meeting.
- **Committees:** Most of the Association's accomplishments come through the work of its five committees; the Executive Committee, Alumni and Faculty Support Committee, Events and Public Relations Committee, the Student Relations Committee and the Chapter Support Committee. Each director is expected to serve on one of these committees.
- **Recruiting & Soliciting:** Directors need to be willing and able to ask fellow alumni to get involved in the association. Involvement may include volunteering at events, purchasing tickets, donating items, making donations or advocating for the University.

Selection of new directors for the board is a competitive process.
